To everyone else - Just a reminder that very important deadlines are almost upon us and here is absolutely no leeway with these. All payments are made on a team basis and failure to meet deadlines will mean the 'team' is withdrawn from competition.

### **IMPORTANT DETAILS AND DEADLINES –**

- **By 20<sup>th</sup> March 2011** - Final date for confirmation of alternative date for return travel  
- Return Travel form
- **By 25 March 2011** - Payment of balance due for travel and accommodation (Athletes and Supporters)  
- **Send copy of Passport (date change to avoid fuel surcharges)**  
(Please refer to amended cancellation clause details)
- **By 1st April 2011** - Return completed Medical Certificates (athletes)  
- General Waiver (**Everyone – athletes and supporters**)  
- Confirmation of travel insurance

### **FINAL PAYMENTS**

Final payment for **travel and accommodation** is due on or before **25<sup>th</sup> March 2011**

Adult	<b>\$4,900</b>	(\$5,500 less \$100 Airline deposit and \$500 registration deposit)
Aged 13-17	<b>\$4,590</b>	(\$5,190 less \$100 Airline deposit and \$500 registration deposit)
Aged 4-12	<b>\$3,770</b>	(\$4,370 less \$100 Airline deposit and \$500 registration deposit)

The **uniform** allowance of \$500 per person has been deducted from original costs (e.g. \$6,000 per adult now \$5,500). A separate payment will be required for uniform purchases.

**SPONSORSHIP** is still a work in progress. Film evening this coming Sunday, Trade Me still has some items available – closing this coming Sunday also.

### **FUNDRAISE ONLINE**

The athletes who have set up pages have received good support. These athletes will be advised the amount they will receive by 25<sup>th</sup> March.

**CANCELLATION CLAUSE** to avoid fuel surcharges ticketing for airfares will be 31<sup>st</sup> March 2011.

Any cancellation of airfares after that date will incur \$450 cancellation fee per person.
